### 1 General Terms

---

- 1.1 I understand that I/my child/children/my students should not participate in this event/events unless I am/he or she is/they are in a fit state physically and mentally to compete the event safely. I acknowledge that if I am aware of an existing medical condition and/or uncertain of my/his/her/their state of fitness then a medical practitioner should be consulted prior to participating.
- 1.2 I consent to receiving any medical treatment including ambulance transportation in circumstances where a coach determines as a result of a health incident during or after the service provided or event.
- 1.3 If I /my child/my student's is/are feeling unwell they will not attend any services
- 1.4 I have disclosed, provided, written, emailed or attached to my enrolment details of any medical, physical and behavioural conditions from which I suffer that might affect my performance or be relevant if medical treatment is needed, including any allergies or injuries. I have supplied an emergency contact name and number.
- 1.5 Handball Australia Association Pty Ltd is not liable for any lost personal possessions.
- 1.6 Although Safety precautions are undertaken by coaches and organizers (such as cones, first aid, staff training, safety instructions are a service to me and other participants) it is a requirement that participants need to act responsibly and sensibly in events and any other service.
- 1.7 My service registration is not transferable to any other person or other event/service. Any attempt to transfer my entry, gain entry without enrolling or allow another person to participate under my name may result in cancellation without refund, insurance being deemed void and inability to enter further services or events.
- 1.8 You, your child/children/OSH/School are insured with Public Liability \$10,000,000 and Professional Indemnity \$1,000,000 under Handball Australia Association Pty Ltd underwriter Dual Australia Pty Ltd. - 2.1 All adult coaches have a Valid NSW working with Children Check or QLD Blue Slip
- 2.2 Senior coaches and above have First aid. I am a student/parent/legal guardian, OSH or school and consent to staff providing appropriate first aid
- 2.3 Been trained and abide by Handball Australia Pty Ltd policies and process. Been given coaching guidelines booklet and a schedule for each event and service

## **3 Rewards**

- 3.1 Accept rewards such as trophies, medals, hats, balls, ice blocks, lollies or prime drinks (hydration versions, no caffeine, 1 gram sugar). Inform us if your child/OSH or school does not allow Prime. In circumstances where there maybe allergy issues or your child is not allowed food, please inform us.

## **6 Refunds, Credits, Makeups, Cancellations or Transfers**

---

- 6.1 Group lessons & Privates. Service can be refunded, credited or transferable to the following term. Cancellation must be made within 1 hours of the lesson. Transfer to another class/day/time during the term period is permitted pending vacancies. Group

privates: If one person cancels and the other student attends, its considered a completed lesson and no makeup is given.

- 6.2 School Sport: On rainy days, hot day, away or cancelled we provide wet weather program. If cancelled and no wet weather indoor program, no refund, credit or makeup is given.
- 6.3 Refunds and/or credits will be given for person injured, excessive rain delays or excessive heat for Comps, camps, privates, weekly coaching or Birthday parties not school sport programs

## **7 Holiday Camps and excursions**

---

- 7.1 Handball holiday camps. Brisbane, Gold Coast and some Sydney camps are indoor facilities and service is on rain, hail or shine. Sydney East provides a wet weather program at Fox Studios. Including movie theatre, amazing race challenge and play centre. Sydney North is outdoor and there are no wet weather facilities. We will cancel if too wet and SMS you 1 hour before event. If your child is away, sick or injured and have a casual booking you may cancel (1 hour notification must be given), full refund, credit, rebook/transfer another day or credited to another camp is given.
- 7.2 Give permission for me/my child/children when registered in our coaching services, camp or competitions to participate or be involved in
  - a) Shuttle bus transportation when purchased and where needed
  - b) Indoor sports facility entry
  - c) Excursions (Internet café or Timezone)
  - d) Ten pin/strike bowling
  - e) Movie excursions
  - f) Inter club, challenges and all affiliated excursions at camps throughout term coaching
  - g) Sport classes, private lessons, Christmas party or special events.

## **8 Enrollments and Discounts**

---

- 8.1 Enrolments: Must be made on our website. If you cannot process payment please request and invoice
- 8.2 Discounts: Only apply via payments online, with the code and by the due date. Special discounts - Only applicable to that immediate family members or siblings.
- 8.3 Refer a friend discount
  - (a) Referral code - will be emailed to you.
  - (b) Your friends use your code and they gets \$10. Once they enrol (you) the referrer gets a new \$10 discount code.

- (c) Unlimited sharing of referral code. The \$10 referral/discount code will be unique and can only be used 1 time. Each successful referral will lead to a \$10 discount code. So if the referrer successfully referred 10 friends, he/she will get 10 unique \$10 discount codes, total value \$100. Can be used for a single transaction. In other words referrers can't use 2 coupons in a single transaction.

Fees will not be refunded. Any repairs, clean-up costs will be charged and will be the liability of you, the parent or guardian.
